Processing of personal data

This page describes the way in which this website manages the personal data of users interacting with the services on the website of Mondall SRL.

This information is only given for this website, not for any other websites that the user may visit through links.

As required by Article 13 of Regulation (EU) 2016/679 (GDPR), this company as Data Controller informs you that your personal data will be processed with respect for the basic freedoms and dignity of the data subject, with particular reference to confidentiality and personal identity, and to the right to protection of personal data.

In accordance with Article 13 of the Regulation, we therefore inform you as follows:

Navigation data

The computer systems and software procedures that operate this website acquire some personal data during normal use, which is transmitted using Internet communication protocols.

This information is not collected to identify you personally. However, it could be used to identify you via processing and in association with data held by third parties.

This data category includes IP addresses or the domain names of the computers used by any user connecting with this website, the URI (Uniform Resource Identifier) addresses of the requested resources, the time of such requests, the method used for submitting a given request to the server, returned file size, a numerical code relating to server response status (successfully performed, error, etc.), and other parameters related to the user's operating system and computer environment.

These data are only used to extract anonymous statistical information on website use as well as to check its functioning; they are erased immediately after being processed. The data could be used to ascertain liability in the event of possible crimes against the website.

Data Provided Voluntarily by Users

If emails are sent voluntarily to the addresses indicated on this website, the sender's email address will then be stored together with any other personal data in the email, in order to reply to the request or query.

Specific summary information notices will be shown or displayed on the website pages that are used for providing services on demand.

Your personal data will only be used for purposes connected to and/or instrumental to browsing the website, and therefore any other use that conflicts with the purposes of the data subject is excluded.

Your personal data will be processed in accordance with the principles of fairness, legality, transparency and confidentiality, using electronic tools or on paper, for the time strictly necessary to fulfil the purpose for which it was collected.

Specific security measures are implemented to prevent the data from being lost, used unlawfully or inappropriately, and accessed without authorisation.

Provision of the data is optional, however any refusal to provide personal data that is relevant to the purpose for which it is collected, will mean that the requested service cannot be obtained.

The processing of data connected to the services on this website will take place at the offices of Mondall SRL and will be performed by our data processors and hosting providers.

Your personal data will not be disseminated under any circumstances, except with specific consent.
